



TERMS AND CONDITIONS

1. ABOUT ACTIVITY TABLE CO

1.3 If you do not agree to these Terms and Conditions, you must not access or use the App or our services.

2. ELIGIBILITY

2.1 You must be at least eighteen (18) years of age to create an Activity Table Co account or purchase a subscription.

2.2 Children may only access and use Activity Table Co under the supervision of a parent, guardian or other responsible adult.

2.3 The account holder is responsible for ensuring that all users of the account comply with these Terms and Conditions.

3. YOUR ACCOUNT

3.1 You must provide accurate and complete information when creating an account.

3.2 You are responsible for maintaining the confidentiality of your login credentials and for all activity that occurs under your account.

3.3 Only the account holder may purchase, manage or cancel a subscription.

3.4 We may suspend or terminate your account where these Terms are breached or where we reasonably believe your account has been misused.

4. FREE TRIAL

4.1 Activity Table Co may offer a free trial from time to time.

4.2 The content available during a free trial may differ from that available under a paid subscription.

4.3 We may modify, suspend or withdraw a free trial at any time.

5. SUBSCRIPTIONS

5.1 Activity Table Co offers access to the App through a recurring monthly subscription.

5.2 An active subscription provides one Subscription Licence for use by the subscriber and members of their immediate family.

8.3 You must not upload harmful, offensive or inappropriate content.

9.1 Parents, guardians and caregivers remain responsible for supervising children using Activity Table Co.

9.2 Activity Table Co is intended to support family interaction and is not a substitute for appropriate adult supervision.
